II. Approval of Minutes Steve Bohn made a motion to approve the June 2019 minutes.



## VII. North Carroll Business Park

He would like the IDA to reconsider beginning preliminary engineering work to finish the 10 acres adjacent to Fuchs. Mr. Lyburn asked for approval for Economic Development to pay for a geotechnical study for boring locations. He also would like to install a marketing sign on the site advertising the price of \$200k per acre.



Mr. Dertzbaugh made a motion to have Mr. Menasche draft an RFP for a geotechnical engineer to perform borings on the site.
