Steve Bohn made a motion to approve April 24 minutes.



### III. BGE grant

Mr. Lyburn said BGE is rolling out a grant program to help small businesses with the financial impact caused by COVID-19 pandemic. They will grant a TBD amount of money to each jurisdiction they do business in. Mr. Lyburn asked the IDA to accept the grant money which would be used under the same terms as the County's Small Business Emergency Relief Grant Fund. It would be available to all small businesses under 25 employees, including home based and sole proprietorships. The total amount of each grant under this program would be \$1,000 per business.

Frank Dertzbaugh made a motion to accept BGE grant funds to be used as described.

# V. Land purchase

Economic Development has been contacted by a broker who has a prospective purchaser for the Dart building in Hampstead. They will need additional parking areas and are interested in purchasing the IDA-owned 10-acre lot adjacent to Dart Cup. The Board discussed the offer and, with certain conditions, agreed to sell the land.

Mr. Yingling made a motion to approve the sales price of \$40,000 per acre (total of \$400,000) and to direct Mr. Menasche to work with the prospective purchaser on a contract.
