Wanda Lynn provided an update of the IDA financials including an overview of the grants the IDA administered on behalf of Economic Development.


Carroll Yingling made a motion to approve the Treasurers Report.

VII. North Carroll Business Park – southern section

Brian Wagner briefed the Board on the development project. CLSI is the engineer for both the IDA and Ridge Engineering. There needs to be an engineering change order to bring Ridge onto the IDA site. Brian is working on a land swap arrangement that would benefit both the IDA and Ridge. There were discussions regarding SWM sharing arrangements and possible cost sharing formulas. Mr. Menasche said the Board needed to be assured that the IDA is getting a benefit from the arrangement and that Ridge's plans do not negatively impact the IDA's plans.
