Mr. Lyburn noted the covenants do allow the Developer to approve modifications to the architectural design, so the Board retains flexibility in its Developer role. After discussion on these items, the Board voted on the covenants as presented.

# b.) Ridge Engineering



The Board discussed the terms of a land sale to Tracey Propco based on net square footage.

Mr. Dertzbaugh made a motion to sell Tracey Propco the net square footage they will require (TBD) to be based on the price of \$50k per acre.
