III. Treasurer Report

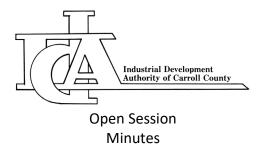
Ms. Lynn noted that CD's have matured and she has researched interest rates for a new account.

- c. Hampstead Welcome Sign
 - a. Mr. Bowersox has been working with the town attorney to ensure that the required land is deeded to the town.

VI. Beaty Property update

Mr. Lyburn briefed the Board on this property. St. John Properties had a contract to purchase the mixed-zoned 100 acres but recently terminated it. A new developer has expressed interest in the property, but they are not interested in developing the 25 acres of I-1 zoned land. He asked if the IDA would like to consider developing this parcel.
